Before me this date personally appeared **LIBERTO, JAMES J. (862)** who being first duly sworn deposes and says that on **19** day of **January**, (year) **2013** at **5141 S UNIVERSITY DR, DAVIE, FL 33328** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

Upon arrival, I made contact with Joshua Socher (victim) who was in a black Infinity (FL Tag 114KII) along with a green Chevy SUV (FL Tag BKTT25) being driven by a female later identified as Analiz Rodzen.

Socher advised that on 1/19/13 at approximately 0920 hours, he was in the drive-thru in his Infinity waiting for service. He was the third car from the window and was patiently waiting in line when a female, later identified as Analiz Rodzen, who was driving a green Chevy SUV began honking the horn.

Socher lowered his window and from inside of his vehicle said to Rodzen that he couldn't go anywhere because he had several cars in front of him. It was at that point that a male, later identified as Nelson Osceola stepped out of the rear seat of the Green Chevy and approached Socher. Socher remained inside of his vehicle as Osceola began yelling at him through the drivers window. Socher attempted to diffuse by telling Osceola "lets just get our food and go on our ways". Osceola continued to yell and then proceeded to open the drivers side door of the Infinity. Osceola then reached in and struck Socher in the face with a closed fist. Osceola then fled on foot from the location. Socher advised he was extremely dazed after the impact and did not see the direction that Osceola fled. Socher advised that he did wish to prosecute and signed an affidavit of complaint. I did observe bruising and swelling to the left forehead area of Socher but he refused medical treatment.

While speaking with Socher, Ofc Garcia advised that he had located an individual in the 7200 block of Griffin Rd matching the description of the suspect. Ofc Corns then transported Socher to the scene for a show up. Socher then positively identified
