EVIDENCE TAKEN BY ..... D/S K. CASTALDO 9355

ON TUESDAY, DECEMBER 29, 2015, AT 1240 HOURS, I WAS DISPATCHED AND RESPONDED TO THE PALM BEACH COUNTY SHERIFF'S OFFICE BELLE GLADE HEADQUARTERS MAIN LOBBY, IN REFERENCE TO AN ASSAULT COMPLAINT.

UPON ARRIVAL, I MET WITH THE COMPLAINANT, HAL HOWARD. HOWARD STATED THAT ON SUNDAY, DECEMBER 20, 2015 AT APPROXIMATELY 1445 HOURS HE WAS LEAVING HIS FRIENDS RESIDENCE LOCATED AT 1150 NE 3RD STREET, IN THE CITY OF BELLE GLADE, PALM BEACH COUNTY, FLORIDA. HOWARD STATED THAT AS HE LEFT THE RESIDENCE IN HIS DODGE RAM PICK-UP TRUCK HE OBSERVED CHILDREN PLAYING IN THE MIDDLE OF THE ROADWAY. HOWARD STATED THAT HE SOUNDED HIS HORN IN ATTEMPTS TO GET THE CHILDREN TO MOVE OUT OF THE ROADWAY SO HE COULD PROCEED DOWN THE ROAD. HOWARD STATED THAT AT THAT TIME, A WHITE MALE CAME UP ALONG SIDE OF HIS TRUCK TO WHICH HE (HOWARD) ROLLED THE DRIVER'S SIDE WINDOW DOWN. HOWARD STATED THAT THE MALE, ENGAGED IN CONVERSATION ASKING ABOUT RELIGION AND ASKED HIM (HOWARD) WHO HIS GOD WAS. HOWARD STATED THAT HE REPLIED, "JESUS CHRIST" TO WHICH THE MALE RESPONDED, "DO YOU WANT TO SEE JESUS CHRIST?" IN WHICH HOWARD RESPONDED BY SAYING THAT WOULD BE GREAT IF HE COULD DO IT. HOWARD STATED THAT THE MALE TURNED TO A CHILD THAT WAS STANDING NEXT TO HIM AND LIFTED THE CHILD UP OFF THE GROUND BY HIS WRIST, SLOWLY BRINGING THE CHILD DOWN TO THE GROUND BACK ON HIS FEET. HOWARD EXPLAINED THAT THE CHILD SEEMED TO BE CONFUSED AND HAD A BLANK STARE ON HIS FACE.

HOWARD EXPLAINED THAT THE MALE THEN EXTENDED HIS HAND AND ARM INTO HOWARD'S TRUCK AS IF HE WANTED TO SHAKE HIS HAND, HOWARD STATED THAT HE LEANED BACK IN THE SEAT WHILE SEAT BELTED IN AND BEGAN TO SHAKE THE MALE'S HAND. HOWARD STATED THAT AS HE WAS SHAKING THE MALE'S HAND, HE REALIZED THAT THE MALE'S GRIP WAS GETTING TIGHTER, HOWARD STATED THAT HE ATTEMPTED TO RELEASE HIS HAND FROM THE HAND SHAKE, BUT COULD NOT DUE TO BEING OVERPOWERED BY THE MALE'S GRASP. HOWARD STATED THAT THE MALE BEGAN TO PULL HIS HAND AND ARM OUT OF THE DRIVER'S SIDE WINDOW TOWARDS THE OUTSIDE OF THE TRUCK BUT WAS ULTIMATELY CAUGHT BY THE SEAT BELT BEING THAT HE (HOWARD) WAS STILL SEAT BELTED IN. HOWARD STATED THAT HE HAD TO FORCIBLY SEPARATE THEIR HANDS WITH HIS FREE HAND TO RELEASE THE GRASP. HOWARD STATED AT THIS POINT HE FEARED FOR HIS SAFETY AND LIFE BEING THAT THE MALE WAS PULLING HIM OUT OF THE TRUCK AND WAS OVERPOWERING HIM. HOWARD STATED THAT HE FELT WITH HIS AGE (65 YEARS OF AGE) AND THE MALE'S PHYSICAL STRENGTH HE COULD OF BEEN SERIOUSLY HURT. HOWARD STATED THAT THE MALE

HAD A STRANGE LOOK ON HIS FACE DURING THE ENTIRE ENCOUNTER AND BEGAN TO YELL "ALLAH, PRAISE ALLAH" WHICH FRIGHTENED HIM MORE. HOWARD STATED THAT HE CAREFULLY AND QUICKLY MANEUVERED AROUND THE CHILDREN AND THE MALE LEAVING THE AREA.

HOWARD STATED THAT HE RECOGNIZED THE MALE AS HIS FRIEND'S NEIGHBOR THAT RESIDES ACROSS THE STREET FROM HIS FRIEND BUT DID NOT KNOW HIM BY NAME. HOWARD STATED THAT HE COULD POSITIVELY IDENTIFY THE MALE IF HE SEEN HIM AGAIN BEING THAT HE HAS SEEN HIM IN THE PAST DURING OTHER VISITS. HOWARD STATED HIS FRIEND, PAT LUCY WITNESSED THE INCIDENT AND COULD CORROBORATE HIS ACCOUNT OF THE INCIDENT. HOWARD COMPLETED A SWORN WRITTEN STATEMENT IN ITS ENTIRETY WHICH HE SIGNED IN MY PRESENCE.

I RESPONDED TO 1015 NE 3RD STREET TO SPEAK WITH THE MALE AT THE RESIDENCE HOWARD DESCRIBED. UPON ARRIVAL, I MADE CONTACT WITH YOUSEF MOHAMMAD MUSLET AT THE FRONT. I EXPLAINED MY REASONS FOR BEING PRESENT TO WHICH MUSLET APPEARED TO BE AGITATED. SIMULTANEOUSLY, SERGEANT SUSZCZYNSKI #5296 WAS PRESENT WITH HOWARD AT WHICH TIME HOWARD POSITIVELY IDENTIFIED MUSLET AS THE PERSON THAT UNLAWFULLY ENTERED AND BATTERED HIM IN HIS VEHICLE. AT THAT TIME, WITH THE ASSISTANCE OF DEPUTIES CAMPBELL #18337 AND CANO #16733 I ADVISED MUSLET THAT HE WAS UNDER ARREST AND ATTEMPTED TO PLACE MUSLET IN HANDCUFFS. MUSLET IMMEDIATELY PULLED AWAY FROM ME NOT ALLOWING ME TO HANDCUFF HIM. AFTER A BRIEF STRUGGLE, I WAS ABLE TO GET ONE HANDCUFF ON MUSLET'S RIGHT HAND IN WHICH HE CONTINUED TO STRUGGLE AND PULL AWAY FROM ME. DEPUTY CAMPBELL AND I GAVE MUSLET LOUD VERBAL COMMANDS TO STOP RESISTING TO WHICH HE WAS ABLE TO BE HANDCUFFED. I ATTEMPTED TO SPEAK WITH MUSLET AND CALM HIM DOWN AS HE CONTINUED TO STATE, "YOU GUYS FUCKED UP NOW, I AM GOING TO GET ALL OF YOU!" MUSLET BEGAN TO SPEAK IN HIS NATIVE LANGUAGE AND BEGAN TO SAY, "ALLAH, ALLAH, ALLAH, I AM GOING TO BRING YOU CARE." MUSLET WAS PLACED IN THE REAR OF DEPUTY DENMAN'S PATROL VEHICLE WHICH WAS RECORDED AND LATER UPLOADED FOR TRIAL PURPOSES.

MUSLET IS BEING CHARGED WITH BURGLARY WITH BATTERY PURSUANT TO FLORIDA STATE STATUTE 810.02(1)(2)(A), BEING THAT HE UNLAWFULLY ENTERED HOWARD'S VEHICLE AND BATTERED HIM. MUSLET IS ALSO BEING CHARGED WITH RESISTING ARREST WITHOUT VIOLENCE PURSUANT TO FLORIDA STATE STATUTE 843.02 BEING THAT HE ACTIVELY RESISTED DEPUTIES WHEN HE WAS TOLD HE WAS UNDER ARREST. MUSLET WAS TRANSPORTED TO THE WEST COUNTY DETENTION CENTER WHERE HE WAS LODGED. DUE TO THE TIME FRAME AT WHICH MUSLET WAS ARRESTED, HOWARD STATED BECAUSE OF THE FEAR AND SAFETY FOR HIM AND HIS FRIEND (BEING HIS NEXT DOOR NEIGHBOR), HE DETERMINED TO REPORT THE INCIDENT TODAY 12/29/2015, THEREFOR WE PERPETUATE THE ARREST ON THE SAME DAY OF THE REPORTED INCIDENT.
