Before me this date personally appeared **PEREZ, DANIEL (769)** who being first duly sworn deposes and says that on **30** day of **March**, (year) **2012** at **NW 62ND ST AND 195, MIAMI, FL** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

with red and blue activated lights and sirens). Def refused to stop, but instead accelerated. Def continued north on I-95, passed NW 79 St 110 MPH in a 55 MPH Zone. Due to pursuit policies the police vehicle no longer pursued, (deactivating emergency equipment) and only maintained a visual from a distance until aviation (air 12 Ofc Wessel 2379/Ofc Rodriguez 7945) located the vehicle. Air 12 maintained visual contact and relayed the vehicle's locations via radio. At Orange Dr and 101 Ave (Davie, FL) def bailed out of the vehicle. Def was located just west of 101 Ave/Orange Dr by Air 12 and Davie K9 Officer Ricker Id 689. Air 12 Ofc Wessel Id'ed the def as the driver who bailed out. Def was transported to Broward County jail via Davie Police station.

Note: Def had 5 suspensions last 07-18-20119 (was given notice 06-27-11) for failure to appear. Def is also on probation for agg fleeing out of Palm Beach, Fl. Hialeah Police off. Alex Cabrera advised bolo. Speeding citation 3155 GYV radar 5896. Affidavit PFC 8 AM ASA Wessel 04-06-2012.

The defendant, Nelson Osceola, was involved in a vehicle pursuit in Miami Dade County, under Metro Dade County PD case PD 120330121029. The def crashed his vehicle at the 10100 blk of Orange Dr and fled on foot. The def was subsequently found in the same area by K-9 Ofc Ricker and taken into custody without incident. I transported Osceola to station for processing. See Metro Dade original report for details, and their probable cause affidavit is attached

The def's Florida driver license was not valid. It was canceled indefinitely on 12/16/2011. The def is on probation for Agg. Fleeing out of Palm Beach county DC number L92404.
