Probable Cause Affidavit

Before me this date personally appeared YEPEZ, MIKE A. (303) who being first duly sworn deposes and says that on 22 day of July, (year) 2011 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

backyard pulling on her rear sliding glass door. The victim further stated that her rear slider was unlocked however she had placed a broom stick in between the doors. The stick prevented the DEF from making entry into the residence and made for a loud noise that woke up the victim's husband. The victim and her husband knocked on the window causing the DEF to take off running.

The victim stated that she had a clear and unobstructed view of the DEF from her window. The victim called 911 and gave the following description of the suspect: hispanic or light skin black male, early to mid 20s, short faded hair, 220 lbs, large stomach, no shirt, blk shorts and blk shoes.

Officer's responded to scene and a perimeter was established. The suspect was not located at this time. At about 0830 hours I responded to 2497 SW 126th Way in reference to a suspicious person. Upon further investigation I responded to 12686 SW 22nd CT to follow up on the attempted burglary incident. Contact was made with the DEF in front of the residence while attempting to leave in a white Suburban. The DEF matched the description given earlier by the victim.

A show up was conducted and the victim advised she was 100% sure that the DEF was the subject she had observed in her backyard earlier in the morning.

The DEF was taken into custody and transported to the Miramar Police Department for booking.

Upon arrival the DEF was escorted to the interview room. Post Miranda the DEF provided
